

## **Appendix A: Social Distancing Protocol**

**Business name: Tayman Park Golf Group, Inc. (Fairgrounds Golf Course)**

**Facility Address: 1350 Bennett Valley Road, Santa Rosa**

### **Signage:**

X Signage at each public entrance of the facility to inform all employees and customers that they should: avoid entering the facility if they have COVID-19 symptoms; maintain a minimum six-foot distance from one another; sneeze and cough into a cloth or tissue or, if not available, into one's elbow; wear facial covering, as appropriate; and not shake hands or engage in any unnecessary physical contact.

X Signage posting a copy of the Social Distancing Protocol at each public entrance to the facility.

### **Measures to Protect Employee Health (check all that apply to the facility):**

Everyone who can carry out their work duties from home has been directed to do so.

X All employees have been told not to come to work if sick.

X Educated employees and management to carry out COVID-19 mitigation plans and protocols.

X Provide training to employees on COVID-19 mitigation measures for customer-facing activities.

Temperature checks to verify the employee's temperature is below 100.0 F before entry into workplace.

X Symptom checks are being conducted before employees may enter the work space.

X Employees are required to wear facial covering, as appropriate.

All desks or individual work stations are separated by at least six feet.

X Break rooms, bathrooms, and other common areas are being disinfected frequently, on the following schedule:

Break rooms:

X Bathrooms: Twice per shift
